

**FLOCK GROUP INC.
AMENDMENT**

This amendment (the “**Amendment**”) is made between Flock Group Inc. (“**Flock**”) and CA - Vallejo PD (“**Customer**”), collectively referred to as (the “**Parties**”).

1. Scope. This Amendment supersedes and amends the previously executed agreement between the Parties, dated 8/13/2024, relating to the provision of services by Flock to Customer and any schedules attached thereto or incorporated therein by reference (the “**Agreement**”). The remainder of the Agreement shall remain in full force and effect.
2. Conflict. In the event of a conflict between this Amendment and the Agreement or any previous amendment, the terms of this Amendment will prevail.
3. Capitalization. Any capitalized terms used in this Amendment will have the same meaning as in the Agreement, unless expressly defined otherwise.
4. Effective Date. This Amendment will become effective when executed by both Parties (the “**Effective Date**”).

The Agreement is amended as follows: Section 4.3 Anonymized Data shall be struck. Section 5.3 is amended to: “Disclosure of Footage. Subject to and during the Retention Period, Flock may (1) access, use, preserve and/or disclose the Footage to law enforcement authorities, government officials, and/or third parties, if legally required to do so by an order from a court of competent jurisdiction or a valid subpoena issued by a court of competent jurisdiction. (2) if Flock has a good faith belief that such access, use, preservation or disclosure is reasonably necessary to comply with a legal process, enforce this Agreement, or detect, prevent or otherwise address security, privacy, fraud or technical issues, or emergency situations, Flock may preserve the data but customer’s written authorization shall be required before any disclosure. However, customer may take whatever action it deems necessary or advisable to prevent such disclosure. In the event of an emergency involving immediate risk to life, limb or property Flock may disclose the data subject to the indemnification set forth herein. Flock shall notify customer immediately about any such emergency disclosure. Flock shall, to the fullest extent permitted by law, indemnify and hold Customer harmless for any such disclosure by Flock that is negligent or willful and for the wrongful disclosure or use of the footage arising from such disclosure. Flock shall pay all damages, costs and attorney fees of Customer for any action of any kind against Customer related to or arising from Flock’s negligent or wrongful disclosure of any such footage. Flock acknowledges and agrees that Flock has been provided a copy of the Customer’s Policy (Policy) relating to shared data, including disclosure of footage, and that Flock acknowledges and agrees to the provisions of the Policy relating to prohibited uses/disclosure and will not, pursuant to any section of this Master Agreement disclose footage which is related to a prohibited use pursuant to the Policy or a violation of California Law. In the event that Flock has a good faith belief that it is required by law to disclose data/footage that does not comply with the Policy or California law, Flock will promptly notify Customer of such belief. Customer may take any action it deems necessary or advisable to prevent such disclosure.”

By executing this Amendment, Customer represents and warrants that it has read and agrees to all of the terms contained herein.


